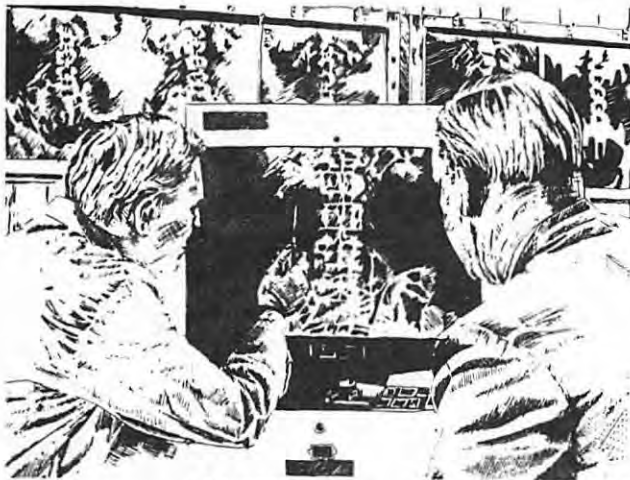

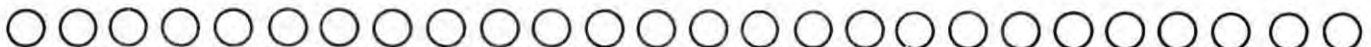

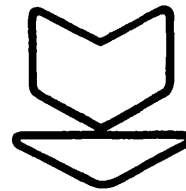

## Consumer-Patient Radiation Health and Safety Act of 1981

It is with a great deal of pleasure in my first Presidential Newsletter to announce the passage of our formal legislation after 12 years of effort. Congress endorsed the legislation on July 31, 1981, as Subtitle I of the Omnibus Reconciliation Act of 1981.

The provisions of our licensing act shall become effective October 1, 1981. In short, this legislation will require all individuals administering x-radiation in medical and dental examinations to be licensed to practice. The Secretary of Health and Human Services, must by October 1, 1982, consult with various groups, and promulgate minimum standards for accreditation and certification of persons administering radiologic procedures. All radiologic technologists must then meet "minimum educational standards" which are currently being established by ASRT. States will be allowed a period of three years in which to comply with the provisions of the act.

Congratulations to us and our sincere thanks to all those who for so long have labored toward this end.

## Dues Increase

Over the past year, ASRT members have received information concerning the financial state of our Society. These intense efforts to provide detailed information have been made to help the members better understand the painful reality of the situation. The two-time defeat of the previous dues increase request has prompted many questions--both from the members and the Board of Directors. The unprecedented third-time request for the \$30 increase to all existing ASRT membership categories was unanimously passed by the members at the Salt Lake City Annual Meeting. We are still trying to reach all those who have not had benefit of information that supports the dues increase recommendation. I assure you there is absolutely no other way to ease this financial problem. The only alternative to the defeat of this dues increase is the end of ASRT.

The mail ratification will be sent to you in late September. I urge you to vote "yes" for the dues increase. If you are still in question about the issue, ask someone to clarify it. Call or write your Regional Director, the Officers, or the Executive Office. You will receive an answer.

If you do not support us now, no one will. Vote yes and return your ballot.



## Donations and Pledges

Following discussions of the Society's financial situation at the Salt Lake City Annual Meeting, the members responded in a most memorable affirmation of faith and concern for our future. Some 20 states, affiliates and individuals provided donations and pledges to be used specifically for maintaining communication to the members. The Presidential Newsletter was revived and there were many funds tagged as discretionary once lines of communication were reestablished. My sincere thanks to all who have supported us with these donations and those who pledged. You could not have begun my year as President in a more positive manner. Thank you.

## Bylaws-ASRT and Affiliate Society

One of the motions that passed at the Annual Meeting that may change our entire organization is a motion by the members recommending "that the ASRT Board of Directors refer to the Resolutions and Bylaws Committee a complete review and possible total revision of the ASRT Bylaws, and the Bylaws for Societies Affiliated with ASRT." Mr. Gary Tomaszewski, R.T., Chairman of the 1981-82 Bylaws Committee has already begun coordination of his committee's efforts toward completing this motion. His committee members are: Mr. Robert Cox, R.T.(Maryland), Mr. Eldon Tuttle, R.T.(Kansas), and Mr. Al Robinson, R.T.(Nebraska). If you have any suggestions as to changing the current bylaws, then communicate with the Bylaws Committee. Mr. Tomaszewski can be reached at the following address: 2582 Meadow Lane, Cocoa, Florida 32922. Feedback concerning the bylaws revision will be appreciated by no later than September 15, 1981. Let's help our Society by updating our bylaws to meet our current goals, purposes and needs.

## Open ASRT Board Meeting

During my inauguration address, I had the extreme pleasure of inviting ASRT members to attend our Post-Board of Directors Meeting. This is your organization and the invitation was accepted by 10-15 members. My thanks to all of you who attended and to continue this precedent, the Board of Directors invites you to attend again at our 1982 Pre-Annual Meeting Board Meeting. To facilitate your direct input to the Board, a specific time has been planned on the pre-Board agenda to allow your participation. On Friday, July 2, 1982 from 3 - 5 PM, we invite you to bring specific requests or issues and address them to the Board. I have only one special request, and that is that to maintain an order in addressing the issues, please contact me in advance with your request. I shall number them based on their order in reaching me. We would like to continue the open discussion that the Salt Lake City Annual Meeting provoked, and I am sure you will agree that we can better accommodate with preplanning. As the 1982 Annual Meeting plans draw nearer, there will be more information about this "open Board session". Let me hear from you in the meantime.

## 1982 NEMA Competition

Do not forget that the 1982 NEMA Competition deadline for submission of a technical essay is MIDNIGHT, DECEMBER 1, 1981. Competition rules and guidelines can be obtained from the ASRT Executive Office. The competition is open to ASRT active members and student members.



## Nominating Committee

The Nominating Committee, Chaired by Linda Weiss, R.T.(New York) has been active since they were charged as directed in Chapter IX of the ASRT Bylaws. The committee is receptive to nominations from both individual ASRT members and affiliate societies. I might suggest that you review Chapters IX and X of the ASRT Bylaws that outline the charge to the Nominating Committee, as well as list the duties of the officers and other elected officials. In the next Presidential Newsletter, the Nominating Committee Guidelines will be listed to provide the members a more accurate idea of the nominating deadlines and official procedures.

## Alternate Dues Payment Plan


During the Pre-Board meeting, the Board of Directors approved an alternate dues payment plan. This action was prompted based on the pending dues increase ratification. IF THE DUES INCREASE IS RATIFIED, the following will be the procedure for those who choose to pay by this method. Remember you still would have the option to pay all at once. "The alternate plan would include two separate payments and a \$5 service charge. Payments would be made in the amount of \$32.50 for each 6 month period. For those just joining ASRT for the first time, the \$5 "new member" processing fee will continue to apply.

# ASRT NEWS RELEASE

Resulting from 12 years of continuous effort by the ASRT, Congress has endorsed Subtitle I - "Consumer Patient Radiation Health and Safety Act of 1981" which will require all individuals administering x-ray radiation in medical and dental examinations to be licensed to practice.

Provisions of this Act shall become effective October 1, 1981. No later than twelve months after the effective date of the Act, the Secretary of Health and Human Services in consultation with various groups shall by regulation promulgate minimum standards for accreditation and certification of persons administering radiologic procedures.

All radiologic technologists must then meet "minimum educational standards" currently being established by the ASRT. Basically these educational standards would mandate that the technologists graduate from a two year program offered by a college or a specialized school, ASRT Executive Director Ward M. Keller, R.T. explained. Presently this certification is voluntary. States will have three years to comply.

Out of approximately 170,000 persons administering x-ray examinations, Keller estimated that 50,000 - 70,000 are not credentialed. Although all specifics are not yet determined, there will be some provisions for those uncredentialed individuals already employed as technologists.

The largest professional association of radiologic technology, the ASRT has endured a lengthy struggle for passage of this legislation. Since 1974, Keller and other ASRT leaders have presented legislation on a yearly basis in favor of the law. Last year five bills were introduced in Congress. Quoting a number of Senators and Congressmen, Keller asserted that this year, "the time has come."

According to Congressional rationale, "it is in the interest of public health and safety to minimize unnecessary exposure to potentially hazardous radiation due to medical and dental radiologic procedures."

Expressing his "absolute delight" Keller responded, "It is my belief that we now have a mechanism to protect the public from unnecessary radiation."

While opponents of the legislation argued that requiring credentialing would increase the costs of medical care, Keller maintains that the law will actually lower costs. Not as many x-rays will have to be repeated because the qualified technologist knows the precise area to be radiographed, he noted, adding that this would eliminate unnecessary time and x-ray film.

James A. Mom, R.T., La Mesa, California was voted President-Elect of ASRT according to the election results. Mr. Mom's victory will place him on the Board of Directors for three years. Mr. Mom has served the California Society as Vice-President and as President. He has also served as ASRT Regional Director (Region I) since 1978.

November 8-14, 1981 has been selected as the date for the 3rd Annual National Radiologic Technology Week sponsored by the American Society of Radiologic Technologists on behalf of its 54 Affiliated Societies. President Marilyn Holland announced that the new dates for this event will appropriately observe the 81st anniversary of William Roentgen's discovery of x-rays.

# COUNSELORS CORNER

Effective September 1, 1981, full ECE credit (1/contact hour) will be given for district activities after presentation, if program materials are submitted to the Counselor within 48 hours of presentation and meet the established criteria for approval. The Council interprets "within 48 hours of presentation" as delivered to the Counselor or post-marked within 48 hours of presentation.

## NEW

In response to requests, the Council is asking Counselors to be as flexible as possible with the 30 day requirement of submission for approval. The intent of the 30 day requirement is to promote program planning by Sponsors. Counselors are encouraged to work with Sponsors to approve educational activities with less than 30 days notice whenever possible.

The Council voted that ECE participants may be awarded up to 100 credits at the completion of formalized non-degree educational programs, post R.T. certification if the Council on Continuing Education has reviewed and approved the curricula. Example: Special Vascular Imaging Program. Credit will be awarded upon receipt of participant's name, social security number and copy of certificate verifying completion of such education from a program which has been reviewed by the Council. A policy already exists whereby ECE participants certified in one discipline, who complete an educational program in another certificate discipline may document credit. Until now, no mechanism existed for non-certifiable advanced education.

### OTHER CREDIT

Some of the educational activities at the 1981 Annual Meeting were taped. These tapes were sold at the meeting and are available on a continuing

basis. Since these presentations were ECE approved, the tapes are approved on the basis of 1 ECE credit/contact hour. These tapes can be used at district meetings. Sponsors complete a Request for Approval identifying the program by name with the notation "ASRT '81". A copy of the proof of purchase is the only supporting material needed. Individuals may utilize these tapes on a self instructional basis. Credit will be documented by submitting to the ASRT Department of Education the following: Participant's name, social security number and copy of a proof of purchase.

I am pleased to publish these new ECE guidelines and I hope that districts will contact me with any questions that they may have. Better yet, I hope to receive more applications for approval under the new guidelines.

# UPDATE ON LEGISLATION

## Special MSRT Legislation Meeting

### NATIONAL LAW

On Saturday, September 12, 1981 at 10:30 A.M. a special meeting was held at the Mallinckrodt Institute of Radiology, St. Louis, Mo., to discuss the recently passed FEDERAL MINIMUM STANDARDS. The bill, properly titled "Consumer-Patient Radiation Health and Safety Act of 1981" represents the culmination of efforts that were first initiated by the ASRT in 1967.

This bill was passed by Congress on July 31, 1981 as "Subtitle I of the Omnibus Budget Reconciliation Act of 1981". Its basic content is briefly described in an Affiliate News Press Release from the ASRT. (See News Releases: Editor) This law goes into effect on Oct. 1, 1981.

### STATE LEGISLATION

Through the courtesy of Mr. Ulysses Murray, who chauffeured Representative Johnnie Aikens to and from the meeting, those present were able to learn much about Missouri Legislative tactics. Mr. Aikens who is Chairman of the Licensure Committee in the Missouri House of Representatives was informative and very helpful. He answered many questions and ended his presentation by saying that he would be a co-sponsor to our proposed state legislation.

### DISCUSSION

After lengthy discussion regarding the new federal law it was decided to continue pursuit of State Licensure. The Federal law will require up to 3 years for implementation. The state will be required to pass legislation eventually. It was felt that it would be advantageous to have achieved state regulation prior to the federal requirement.

### ACTION

A Special Legislation Meeting for the membership is to be held at 4:00 p.m. Thursday, October 29th, 1981 at the MSRT Annual meeting. This special meeting will offer members an opportunity to question and to learn about all legislation activities, state and national.

### HEARINGS ON OCCUPATIONAL LICENSURE

On September 15, 1981 in St. Louis Aona DeClue and Beth Anderhub testified before the "License and Related Matters Committee". Chaired by Johnnie S. Aikens of the Missouri House of Representatives, this committee will consider our state licensure bill. In addition to the pro-testimony of Aona and Beth, Ulysses Murray was present to offer moral support.

On September 22, 1981 in Kansas City Gerald Schaumburg and Dennis Hronek testified for our bill before the same committee.

On October 6, 1981 in Jefferson City M.S.R.T. President Judy Foeste and Eastern Counselor Norman Hente plan to testify for our bill.
